

Terms and conditions Ledgnd World Cup Pool 2026

1. General

These terms and conditions apply to participation in the Ledgnd World Cup Pool 2026, hereinafter referred to as “the World Cup Pool”. The World Cup Pool is organised by Ledgnd B.V., hereinafter referred to as “Ledgnd”.

By participating in the World Cup Pool, the participant agrees to these terms and conditions.

2. Participation

The World Cup Pool is intended for individuals who work in or are connected to the horticultural sector and/or related industries.

Participants must register with accurate and complete details, including first name, last name, company name and email address. Ledgnd reserves the right to exclude participants if their details are incorrect, incomplete or misleading.

Participation in the World Cup Pool is free of charge, unless explicitly stated otherwise.

3. Operation of the World Cup Pool

Participants can submit predictions for matches during the FIFA World Cup 2026 via the platform. Points are awarded based on the accuracy of these predictions.

Ledgnd determines the scoring system, rankings, game rules and any additional conditions. Ledgnd reserves the right to amend the operation, rules or scoring system of the World Cup Pool if this is necessary to ensure fair and proper participation.

In the event of technical failures, input errors, incorrect data, force majeure or other circumstances beyond Ledgnd’s control, Ledgnd shall not be liable for missed predictions, incorrect allocation of points or any other consequences for the participant.

4. Company pools

In addition to individual participation, participants may also take part in a company pool. A company pool may be created by a company administrator.

The company administrator is responsible for inviting colleagues or other participants within the organisation. The company administrator must ensure that invitations are only sent to individuals who can reasonably be considered part of the relevant organisation or group.

Ledgnd reserves the right to review, amend or remove company pools in the event of misuse, incorrect data or violation of these terms and conditions.

Ledgnd may use photographs, names, company names, quotes and other contributions created or provided in this context for communication and marketing purposes relating to the World Cup Pool and related horticultural activities.

10. Privacy and data protection

Ledgnd processes personal data carefully and in accordance with the General Data Protection Regulation, hereinafter referred to as "GDPR".

Personal data is processed for the following purposes:

- registration and participation in the World Cup Pool;
- account and company pool management;
- communication about participation and matches;
- rankings and scoring;
- prize allocation;
- marketing communication, where consent has been given;
- analysis and improvement of the World Cup Pool;
- compliance with legal obligations.

Ledgnd does not retain personal data for longer than necessary for the purposes for which it was collected, unless a longer retention period is required or permitted by law.

Participants have the right to access, correct or delete their personal data, and to object to certain types of processing. Participants may also withdraw their consent for marketing communication at any time.
